## Energy

We have assisted in drafting particular conditions of contract for projects as well as representing clients before FIDIC Dispute Adjudication Boards, in arbitrations and in litigation. Many of these projects had bespoke contracts while others were under amended FIDIC forms, including the FIDIC Silver Book, or MF1.

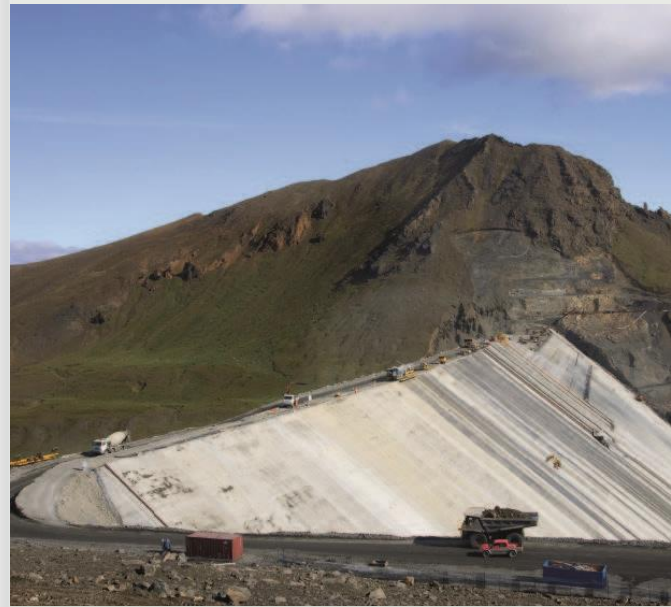
The types of work that our lawyers have undertaken include: defects in the design and construction of a coal-fired power station in Serbia; arbitration and litigation relating to defects in air separation units and gas dryers; a dispute on the rehabilitation and upgrading of the Soviet era Maritza III power station in Bulgaria; a dispute arising out of the refurbishment of the 400 MW gas-fired combined-cycle power station in Ireland; several hydroelectric power project disputes; and several wind farm disputes.

## Dredging

Corbett & Co's lawyers have experience in dredging works across Europe, India, Asia and Australia. Edward Corbett is one of the leading experts in this field having assisted in the drafting of the FIDIC Blue Book. Corbett & Co has worked on a variety of projects from land reclamation and beach nourishment to maintenance and capital dredging works. We have experience of all types of dredging equipment.

We have assisted clients at the procurement stages and drafted and reviewed specific conditions of contract under FIDIC's Blue Book, Yellow Book and Orange Book. We have represented clients before Dispute Boards and in arbitration and prepared claims for submission to an engineer.

The types of work that our lawyers have undertaken include: advising on the construction contract for reclamation of land for a housing project; advising on disputes in relation to a shipping channel and bank protection works; DAB and ICC arbitration proceedings dealing with geotechnical issues and the discovery of ordnance in Europe; and High Court litigation in relation to the non-performance of a submersible dredger.
